(v) 5 % seats for economically backward students are shown in addition (+). Economically backward students are those whose Parents / Guardian income is less than Rs.4.5 Lacs per annum.

(vi) The seats shown for private institutions are valid after AICTE / Deptt. of Sc. & Tech., Govt of Bihar approval only. The recognition of AIT Lakhisarai is reported to has been cancelled by the AICTE.
